**From the President ~**

Last year at our Annual Meeting I announced that I would not run for reelection when my term as president ends in June, 2011. I did this because it was time for a change – and our League now has a lot of good people who are capable of stepping into leadership roles. At the time I didn't know that my husband would get brain cancer, making it absolutely necessary that I be available to support him. It was good that the decision had already been made.

Our nominating committee, under the leadership of Janice Burns, has been meeting frequently and working diligently to develop a full slate for next year. They report that they have someone for president, vice-presidents, and board members. Diane's term as treasurer doesn't end till 2012, so that leaves the position of secretary still to be filled.

I want to appeal to any of you who haven't already agreed to serve on the board to **consider becoming secretary**. The position is a great way to get to know what is happening in the League and to know the players, but it doesn't require you to have experience in the League. You do have to be available to attend most board meetings and to be able to write a sentence. **Call Janice at 587-3436 if you are willing to be nominated for this position.**

May's Bulletin will have the reports of the by-laws, nominating and budget committees and any other information you need for the Annual Meeting on June 5th (the by-laws require that you get at least 30 days notice of these things).

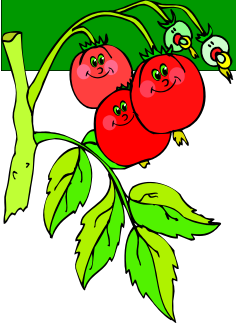
**This League now has a cell phone and a number of its own: 518-728-0237.** The phone will be passed from president to president (or to someone else if the president is away) so that the LWV of Saratoga can always be contacted. We are working to get this number listed on our publications and in community directories.

LWVUS reports that **"the LWVUS study on the "Role of the Federal Government in Public Education"** is well underway. The study on the federal role in pre-K through grade 12 public education is to be limited to issues of equity, funding and standards/assessment. The target schedule is for Leagues to have materials (papers, consensus questions and Leaders Guide for taking consensus) in May. Local Leagues will have from May through November to conduct their local study and take consensus. The committee is writing papers to be posted on the LWVUS website.

The committee will begin with an overview of the history of the federal role and where it is today. They will then focus on the components of the Elementary and Secondary Education act which speak to the equity issues. Finally, the committee will address the Common Core Standards and the subsequent assessment issues. **WILL YOU SERVE ON THE LOCAL STUDY COMMITTEE?** Let me know if you are interested.

## EARTH DAY



On the first Earth Day (4/22/70) 20 million Americans took to the streets, parks, and auditoriums to demonstrate for a healthy, sustainable environment in massive coast-to-coast rallies. Thousands of colleges and universities organized

protests against the deterioration of the environment.

Groups that had been fighting against oil spills, polluting factories and power plants, raw sewage, toxic dumps, pesticides, freeways, the loss of wilderness, and the extinction of wildlife suddenly realized they shared common values.

Earth Day 1970 achieved a rare political alignment, enlisting support from Republicans and Democrats, rich and poor, city slickers and farmers, tycoons and labor leaders. The first Earth Day led to the creation of the United States Environmental Protection Agency and the passage of the Clean Water and Endangered Species Acts.

The theme of this year's Earth Day is: **A BILLION ACTS OF GREEN** Pledge to do something for the environment. A billion individual acts will add up.

**The Environmental Protection Fund (EPF)** has provided more than \$1 billion since 1993 to support critical programs that protect our area's natural heritage, public health, and local industries such as tourism and agriculture. Our local economy and good quality jobs have been enhanced and supported thanks to the EPF, which has pumped **more than \$38 million into our local economy.**

**Jessica Ottney Mahar**, Director of State Government Relations for The Nature Conservancy and **Carol Ash** of the Open Space Institute's Alliance for New York State Parks, formerly Commissioner of the NYS Office of Parks, Recreation, and Historic Preservation, will talk about the EPF and its impact on projects, parks and trails in the Capital District.

**Eating Locally: Farm-to-table's new frontier is local wheat.** Local-food enthusiasts may know where to find ground run chickens, farmstead cheeses and locally grown greens, but where does the wheat in your bread come from?

Matt Funicello, the owner of Rock Hill Bakehouse has started using regionally grown wheat in his

bread. And other, smaller-scale bread bakers around the region are also starting to use regionally grown wheat.

That's because last year North Country Farms, a new stone mill in Watertown began selling its New York-grown wheat flour in the Hudson Valley. Fieldcrest Foods, a small bakery specialty supply company based in Saratoga Springs, distributes the North Country Farms flour.

### Guidelines for Presenting Differing Views of an Issue at a LWV Information Meeting:

1. When the LWVSC does not have a position on an issue every effort must be made to secure representation from all sides of the issue and to locate knowledgeable spokespeople for the various positions.
2. When the LWVSC has studied an issue and arrived at consensus, it is legitimate that we inform the public of our position and why we support the stand. In such cases, it is not necessary to present opposition views.
3. For Voter’s Services activities, for a question that will appear on a ballot it is important that the pros and cons be presented, even when the LWV has a position.

The above policy was adopted by the Board at it’s March 2011 meeting in response to questions raised by some members regarding the meeting on gun control planned for May 19th.

**Robert Freeman** is the Director of the Committee on Open Government, NYS Department of State, one of the few governmental entities in the country dealing with open meetings and public access.

He was enthusiastic, informative and entertaining as he explained the Open Meeting Laws and the Freedom of Information Laws (FOIL) to a large group at the Saratoga Springs Public Library. He briefly outlined the mandate and duties of his Committee, then opened the floor for questions. Every question was answered succinctly in an open, fun, and free-flowing dialog.

Freeman urged the LWV to continue its Observer Corps activities. He stated that merely being a presence is a very effective way to keep government open and democratic. *We have found this to be true.*

The Sunshine meeting was jointly sponsored by our League, the Saratogian, and the Saratoga Springs Public Library.



## Keeping Civil Discourse CIVIL



The topic of an upcoming community workshop sponsored by the League of Women Voters and the Saratoga Vital Aging Network.

**The session will be held on Tuesday, April 12 from 6:30-9pm in the Saratoga Springs Public Library.** It will be facilitated by Nancy Belowich Negron, who works at SUNY Albany and is certified to conduct training for the National Coalition Building Institute's Controversial Issues Process.

Attendance will be limited to 30, with elected officials and civic leaders being strongly encouraged to participate. The program is designed to train leaders to deal constructively with tough conflicts, enabling them to move toward future cooperation. It teaches a set of skills that are essential for effective conflict resolution by mapping out points of agreement and disagreement and then reframing the issue to allow the disputing parties to find common ground. Using a structured methodology, it enables people on both sides of an entrenched issue to express their concerns and to listen attentively to those on the other side in a respectful way that takes into account the concerns of both sides.

The process has been used successfully with members of Congress, church leaders, college students, and firefighters, to name a few, on issues as polarizing and controversial as abortion, capital pun-

ishment, affirmative action, marriage equality, environmental concerns, and assisted suicide.

On April 12, the assembled group will decide what issue they want to use as the vehicle for learning this conflict resolution process; it is not actually about resolving the issue at the session. Participants will simply learn techniques for talking about controversial topics without getting personal or heated.

According to Patricia Nugent, event chair, "The two groups decided to collaborate on offering this program in response to current polarization and heated rhetoric around public policy issues, which affect our members. We have a general concern about how public debate is being framed, and we are looking forward to this opportunity to increase our community's capacity for conflict resolution. We are hoping for strong representation from our elected officials and civic leaders because there are many tough decisions ahead of us, and we want to ensure the best outcomes for those impacted."
