A final note: Our award-winning Voter Services team did a spectacular job this election season, under the leadership of Ann Kril. Yet sadly, that did not stop the perpetuation of some misconceptions about our organization by some local political leaders and bloggers. As members, we are all ambassadors to the community about the League’s mission and strategies. It is important for all of us to proudly acknowledge that LWV is a POLITICAL organization – we do studies, take positions, and lobby for those positions – across party lines. Our having a political yet nonpartisan agenda can be confusing in this day of such sweeping polarized partisan activity. Yet, it would stop the gridlock in Washington if our representatives were able to evaluate the benefits and liabilities of each issue apart from their party affiliation. LWV is a model to be replicated, not feared. Don’t let others make you timid about our political agenda – stand up for it!

And VOTE on November 8<sup>th</sup>! Don’t ever take that right for granted. It is a hard-won freedom.

## ROLE OF FEDERAL GOVERNMENT IN PUBLIC EDUCATION

Our League is one of many participating in the LWVUS study of the role of the Federal government in education. On September 27, League members discussed the funding and equity aspect of education, especially as it affects disadvantaged students. On October 27, League members discussed common core standards and assessments and what the federal role in identifying and monitoring them should be.

Our board will review the consensus report on November 15 and forward it to LWVUS. The national committee will tabulate the results, put together a position paper, and release the new position after its March board meeting.

***Patricia Nugent: our LWV president, opened the first meeting with these words***

“I only have a few minutes but wanted to share part of a paper I delivered at a conference a few years back on the role of public education in a democracy. This short excerpt helps contextualize why the League should be raising this question.

“Since public education was not mentioned in the United States Constitution, it fell to individual states to institute. However, the Northwest Ordinance of 1787 cited the imperative of public purpose, stating, ‘...Schools and the means of education shall forever be encouraged.’ According to David Mathews, a former Secretary of Health, Education and Welfare, public education was considered central to maintaining a democratic form of government in America. A strong new republic was dependent on the skills, knowledge and attitudes that would lead to effective civic engagement. The populace had to be converted from royal subjects to participating citizens, from the governed to the self-governing.

“Mathews makes a compelling case that public education not only has the capacity to instill democratic principles, it has the potential to level the economic playing field and to advance social justice. Yet there is substantial evidence that ideological, political and financial support for public schools is diminishing on the national, state and local levels. At the same time, demands on our public schools are increasing dramatically. Expensive mandates are added each year, standardized testing is more rigorous, and students’ readiness and ability to learn is deeply compromised by personal, home and social issues.”

## STUDY OF PRIVATIZATION OF GOVERNMENTAL SERVICES

From its earliest birth pangs, an inherent necessity for a flourishing democracy has always been a free flowing exchange of information between the governed and their government. Of course, attempts to thwart knowledge of their actions by various governmental entities have arisen. The League of Women Voters and others continuously advocate for more open government. In recent years, Congress has responded by passing “Sunshine Laws” and Freedom of Information Laws to better address openness in federal activities.

Such laws do not cover state and local governments. However, many states have passed laws to try to keep up with that national thrust toward openness.

In the current world-wide movement toward privatization, the question of openness can become an issue. Unless compelled by precise state laws and specific contract provisions, private corporations, engaged to execute public functions and paid by public, taxpayer dollars, can, and often do, claim proprietary rights to their actions, costs, methods, and results. Lack of accountability can result.

Are you comfortable with a private, for-profit prison system? Do you want a French international corporation supplying your water? Can private corporations do a better job of building roads and bridges? Are you looking forward to Wall Street managing your Social Security? Do companies making a profit fighting our wars make sense to you?

If this subject interests you, join us for the LWVUS Privatization of Governmental Services Study Committee. We’ll look at the history and background, legal issues, current regulations, and case studies of privatization efforts. Is there a link between corporate hegemony, governmental malfunction, privatization, climate change, energy, water, food, and environment?

## Compare Where Candidates Stand on the Issues

Starting in October, our league has for the second year released an electronic voter guide to help voters learn about the candidates who will be on their ballots in November. The 2011 Saratoga County Voter Guide is available online through our website at [www.lwvsaratoga.org](http://www.lwvsaratoga.org) and through the League's Vote 411 website at [www.vote411.org](http://www.vote411.org).

The candidates for the Saratoga County Board of Supervisors and the City Councils of Saratoga Springs and Mechanicville were each asked in mid-August to provide background information and to respond online to five questions. Information collected from candidates has been made available on Vote 411, together with basic information about judicial candidates for the Saratoga County Surrogate Court and the New York State Supreme Court for the 4th Judicial District.

Vote 411 allows voters to see a side-by-side comparison of candidates and their positions on the issues. Voters can "build a ballot" of their choices for each race, and print or email these choices to help them remember which candidates they would like to vote for on November 8th. A printable (PDF) version of the voter guide also is available on our [lwvsaratoga.org](http://lwvsaratoga.org) website.

For the first time this year, the League has partnered with The Spotlight Newspapers to produce a printed voter guide that was distributed as a special supplement in the Spotlight. The Spotlight provided hundreds of additional copies of the voter guide supplement to us for distribution to libraries and public places in Saratoga County.

We thank Ann Kril and all of the members of the Voter Services' Committee for their help in producing this important resource for voters.

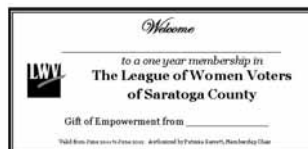
## MARTIN LUTHER KING DAY

## THE FUTURE OF HEALTHCARE

The Capital District Alliance for Universal Healthcare sponsored, with the League of Women Voters of Saratoga County as one of several cosponsors, a forum on "The Future of Our Healthcare: Medicare for All versus a Private Insurance Based System" on September 25, at the First Unitarian Universalist Society of Albany.

The keynote speaker was David Ansell, MD, MPH, currently the Chief Medical Officer at Rush University Medical Center. At the start of his medical practice, he trained at Cook County Hospital in Chicago. What he saw there reinforced his social ideals framed by the '60s and made him an advocate for change. He recently wrote about his experiences at Cook County Hospital in "COUNTY: Life, Death and Politics at Chicago's Public Hospital." Dr. Ansell outlined the measures taken, strikes of the physicians included, to improve care at the Cook County Hospital. He encouraged us to keep up the good fight for healthcare for all through a single-payer system. We must believe that a new healthcare system is possible.

Panelists -- Michael Kaplan, MD, from Massachusetts; Betty Keller, MD, from Vermont, and Mark Dunlea, JD, from New York State -- followed, discussing the current healthcare situation in each of those states. Dr. Betty Keller spoke about Vermont's steps toward universal health care. Every community, even the very small ones, was visited by advocates. Dr. Michael Kaplan, from Lee, MA, talked about his state with the highest percentage of insured people and with the highest medical costs. The largest group of those with health insurance are the underinsured. Insurance will pay for 60 - 70% of their medical expense, but the remainder, co-pays, etc., is unaffordable for most people. So the effect is the same as having no insurance, and bankruptcy can occur even among the insured. Mark Dunlea has many connections in New York State government, and he sounds optimistic.

After a young woman talked about her medical needs and how she was trying to cope without insurance, Andy Coates, MD, moderator of the event, said this was just the kind of story the public needs to hear. The doctors there had good advice for her.

Betty Gallagher and Helen Crawshaw, members of the county LWV and Single Payer New York, were

inspired by what they heard. Ideas worth exploring: a program in our area with Andrew Coates, MD, sponsored by our League with Single Payer; a questionnaire for candidates that includes asking for their stand on health care; divestment of investments in healthcare insurance; visiting our state senators and representative to ask for their support of single-payer healthcare; a Power Point presentation that members of the single-payer committee could use with groups.

## LWV Gives Peace A Chance



*Excerpt from  
Lori Dawson's Address at  
the Opening of Peace Week  
in Saratoga Springs*

“The League of Women Voters has a long history of advocating for issues of peace, nonviolence and equality. We encourage informed and active participation in government, work to increase under-

standing of major public policy issues, and influence public policy through education and advocacy. Much of what follows is taken directly from Impact on Issues – which is our guide to public policy positions. You can find it on the LWVUS web site. It contains our positions as well as the history behind those positions.

“A commitment to international cooperation as an essential path to world peace is deeply rooted in League history. Founded just after WWI, the League rejected a policy of isolationism as “neither wise nor possible for this nation.” As WWII drew to a close, the League helped to educate people about the agreements setting up the United Nations and we are proud to be one of the nongovernmental organizations first affiliated with the UN, a relationship that continues to this day.

“The LWV believes that arms control measures are essential to reduce the risk for war and increase global stability. We believe that the US government should seek to protect its interests at home and abroad through the use of nonmilitary measures, including diplomacy, mediation and multilateral cooperation. The League believes that military force should be used as a tool of last resort.

“We believe that the United States should vigorously pursue arms-control negotiations in order to ensure that all nations reduce and eventually eliminate their stockpiles of strategic nuclear weapons. And lastly, the League believes that defense spending should be examined in the same way as spending for other national needs. Now, more than ever, our political leaders should assess the impact of US military spending on the nation's economy and on the government's ability to meet social and environmental needs.

“From its inception, the League has worked for equal rights and social reforms. In the 1960's with the nation's unrest over civil rights, the League began to build a foundation of support for equal access to education, employment and housing. In the 1990's, a concern for violence prevention spurred a new League position in favor of strong support for common-sense measures to control gun violence.

“ And in June 2010, delegates at the the League of Women Voters national convention in Atlanta, GA expanded our equality of opportunity position to include support for marriage equality. Our local league took the lead on marriage equality by taking the proposal to the delegates at Convention. And once the position passed, we joined League members across NY to lobby our representatives in favor of the marriage equality bill approved in New York State this year. We are proud to have been part of this historic law.”

We hope that you will join us all in our vital work. Thank you.

Our candidate event at Malta on 10/12/11 was successful, with about 40 people in attendance. All

candidates for Town/County Supervisor and for Town Council participated. Our new moderator, Donna Dardaris, did a super job, as did A.C. Riley at the Halfmoon/Clifton Park Forum, where over 125 people attended.

## TAKE ME TO VOTE! is Underway

Mary Ratzer, chair of our TAKE ME TO VOTE! project, reports that she is still contacting and following up with teachers to encourage them to participate. Once again, Mary has drawn on her network of school librarians (through BOCES) to get information and materials to the county's fifth grade teachers. Despite the cutbacks in aides available to teachers and librarians, and the fact that it is a local election year, there is interest in the program.

So far teachers at Corinth, Dorothy Nolan (Saratoga Springs); Orenda (Shenendehowa); Schuylerville; and Woods Road (Ballston Spa) have indicated that they will participate. To date, Mary has distributed about 2,000 student packets.

The goals of TAKE ME TO VOTE! are two-fold. The first is to encourage voter turnout on Election Day. The second is to prepare children for the rights and responsibilities of citizenship. Fifth Grade Students ask an adult to take them to the polls on Election Day. Adults are encouraged to vote, and to interest their children in their rights as citizens. Fifth graders have participated in this program in Saratoga County since 2004.

Every student who goes to the polls with a parent/adult and shows his/her certificate to a poll worker earns a sticker. Teachers provide each fifth grader who participates with a button that says, "Take me to Vote!...Again!"
